\$50 Million to \$100 Million .....	225.00
\$100 Million to \$500 Million .....	275.00
Over \$500 Million.....	325.00

\*Annual dues cover branches or facilities located on a single military installation. For each additional military installation on which the parent banking institution operates a branch or facility, add **\$100.00** to the basic dues.

**ASSOCIATE CORPORATE MEMBERS (NON-VOTING):** Commercial banks or branches of commercial banks serving military personnel but not located on military installations.

Annual Dues.....\$ 200.00

**ASSOCIATE INDIVIDUAL MEMBERS (NON-VOTING):** Individuals interested in banking service for military personnel.

Annual Dues.....\$ 50.00

**ASSOCIATE CORPORATE/INDUSTRIAL MEMBERS (NON-VOTING):** Companies providing services to the military banking industry.

Annual Dues.....\$ 400.00
